

Information clause – GDPR
"Guala Closures DGS Poland" S.A.

Pursuant to Art. 13 section 1 and section 2 Regulations of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons in connection with the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as "**GDPR**"), the company: "Guala Closures DGS Poland" S.A. with its registered office in Włocławek (87-800), Aleja Kazimierza Wielkiego 6, Poland, informs that:

1) The administrator of your personal data is the company: "Guala Closures DGS Poland" S.A. based in Włocławek (87-800), Aleja Kazimierza Wielkiego 6, NIP: 888 284 28 62, REGON: 911361543, BDO: 000008488, KRS number: 0000224737 registered in District Court in Toruń, 7th Commercial Division of the National Court Register ("**Company**"), telephone number (+48) 54 232 06 00, e-mail address: dgs@gualaclosuresdgs.pl

2) Your personal data, in particular: name, surname, business position, e-mail address, telephone number will be processed by the Company for the purpose of cooperation connecting our entities/organizations.

3) The legal basis for disclosing Your personal data is legally justified the interest of the administrator referred to in Art. 6(1)(a) f) GDPR. Legally justified administrator's interest is to establish and maintain a business relationship with you or your entities and/or performance of the contract between us.

4) Your personal data will be stored for the period necessary for implementation and settlement of the contract between our entities, considering the limitation period claims and tax regulations.

5) You have the right to request access to your personal data rectification, its deletion, transfer or limitation of processing and the right to lodge objection to the processing of personal data in connection with processing based on the legally justified interest of the Company, for specific reasons situation, as well as the right to lodge a complaint to the President of the Office for Personal Data Protection in Warsaw, Poland if it is found that the Company has violated data protection regulations personal data, taking into account the restrictions resulting from the GDPR, in particular from Art. 17 paragraph 3 GDPR.

6) Providing your data is voluntary, but necessary for related purposes with cooperation between our entities. Lack of personal data will prevent implementation of our cooperation (including conclusion and implementation of the contract).

7) The processing activities will not involve decision-making automated, including in the form of profiling.

8) Data may be disclosed to authorized employees of the Company and external recipients, including being subject to cross-border data transfer (entities private and public, in particular Guala Group companies and their employees), including: may be transferred to entities and persons providing services to the administrator legal advice (may also be transferred to third countries in connection with so-called processes due diligence), financial, accounting and IT,

etc. in terms of to what extent these data are necessary for the Company to perform its tasks, if required by law or if the Company has a different legal basis.
